

“BUNNINGS NEW ZEALAND EAVES AND SOFFITS PROMOTION” (“Promotion”)

TERMS AND CONDITIONS

1. Information on how to enter and prize details form part of these Terms and Conditions. Entry into the Promotion is deemed acceptance of these Terms and Conditions.
 2. The Promoter is Bunnings Limited, 78 Carbine Road, Mt Wellington, Auckland, 1060, New Zealand (“**Promoter**”).
 3. The Promotion will commence on 18/04/2018 and will continue until 6.00pm NZDT on 18/05/2018 (“**Promotion Period**”).
 4. Entry is only open to businesses located in New Zealand.
 5. Directors, management and the employees of James Hardie (**Prize Supplier**) or the Promoter, retailers and suppliers associated with this Promotion and the immediate family members of those individuals are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
 6. To be eligible to enter, a business must either have an existing Cash, or 30-day Credit Bunnings PowerPass commercial account (each a “**PowerPass Account**”) as at 18/04/2018 or it must sign up for a PowerPass Account during the Promotional Period and prior to entry (“**Eligible Business**”).
 7. For an Eligible Business to be eligible to enter, an authorised representative (aged 18 years or over) of an Eligible Business must first visit www.bunnings.co.nz/jameshardie, follow the prompts to the registration page, input the requested details (including the Eligible Business’ PowerPass Account number, their full name, the Eligible Business company name, a valid email address, and mobile number), agree to the Terms and Conditions by ticking the relevant tick box, and submit the fully completed registration form (“**Registration**”).
 8. Once a Registration has been completed, for an eligible business to enter, an authorised representative of the Eligible Business must then, on behalf of that Eligible Business, complete the below step during the promotional period.
 - a) spend NZ\$300 or more (including GST) when purchasing Participating Product(s) (as outlined in Schedule 1) during the promotional period in any Bunnings store, using their PowerPass or Bunnings Trade Account (“**Qualifying Purchase**”). Existing and new customers must use their PowerPass card or Account Number at the time of making a Qualifying Purchase to qualify for an entry. Holders of Temporary PowerPass cards must present both their Temporary PowerPass card and their Account Number at the time of making a Qualifying Purchase to qualify for an entry. For the avoidance of doubt, an Eligible Business will only be able to receive entries after they have completed a Registration.
- And
- The number of entries an Eligible Business will receive from a single transaction will be dependent on the Participating Product(s) purchased in the Qualifying Purchase, as outlined in Schedule 1 featured at the end of this document. Eligible Businesses must not have overdue balance owing on their PowerPass Account as at 30/05/2018 DRAWDATE in order to be eligible to claim the prize, if drawn as the winner.
9. The Promoter reserves the right, at any time, to verify the validity of entries, authorised representatives and Eligible Businesses (including an authorised representative’s age and place of employment, and an Eligible

Business' PowerPass Account status) and reserves the right, in its sole discretion, to disqualify any individual or Eligible Business who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the Promotion. Errors and omissions will be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.

10. If there is a dispute as to the identity of an authorised representative and/or Eligible Business, the Promoter reserves the right, in its sole discretion, to determine the identity of the representative and/or Eligible Business.
11. Incomplete or indecipherable Registrations/entries will be deemed invalid.
12. Multiple entries permitted, subject to the following:
 - a) only one (1) entry permitted per Qualifying Spend (i.e. per \$300 increment spent during promotional period); and
 - OR
 - b) Eligible Businesses will be eligible to earn the corresponding number of entries outlined in Schedule 1 for each Participating Product(s) they purchase in a Qualifying Purchase; and
 - c) a maximum of fifty (50) entries in total per Eligible Business is permitted.

There will be a total of one (1) prize draw for this Promotion. The draw will take place at 3pm AEST on 30/05/2018 at Orange Box, 6 Te Keas Place, Albany, Auckland 0632.

13. The Promoter may draw additional reserve entries and record them in order in case an invalid entry is drawn.
14. The owner of the winning Eligible Business will be notified in writing and/or by telephone.
15. The prize will be awarded to the owner of the winning Eligible Business who may, in his/her absolute discretion, allocate the prize to any employee of that Eligible Business.
16. The first valid entry drawn will win Apple Products(MacBook pro, Apple watch and iPhoneX) valued at up to \$6000 (including GST). Models may differ from the images shown in the promotional material but will be up to the retail value of \$6000 including GST.
17. The Promoter's decision is final and no correspondence will be entered into.
18. If the prize is unavailable for any reason, the Promoter reserves the right to substitute another prize of equal or greater value and specification for that prize.

If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law:
 - a. to disqualify any Eligible Business; or
 - b. suspend, terminate or cancel the Promotion, as appropriate.
23. Any cost associated with accessing the promotional website is the Eligible Business's responsibility and is dependent on the Internet service provider used. The use of any automated entry software or any other mechanical or electronic means that allows an Eligible Business to automatically enter repeatedly is prohibited and will render all entries submitted by that Eligible Business invalid.
24. Nothing in these Terms and Conditions limits, excludes or modifies or purports to limit, exclude or modify any statutory consumer guarantees as provided under consumer protection laws in New Zealand ("**Non-Excludable Guarantees**"). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion.
25. Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by an Eligible Business or authorised representative; or (f) taking/use of a prize.
26. As a condition of accepting the prize, the prize taker must sign any legal documentation as and in the form required by the Promoter and/or the Prize Supplier in their absolute discretion, including but not limited to a legal release and indemnity form.
27.
